### 15k Race - 1 pm

A point to point, 15K (9.3 mile) race on the Cumberland Valley Rail-Trail starting at the Newville trail head and finishing at the Shippensburg Township Park. The trail has a smooth, crushed stone surface thru beautiful farmland. **Transportation will be provided from the park to the start in Newville for the first 250 entries.**

### 5K Run/Walk - 11 am

A 5K (3.1 mile) run/walk - **Awards to** Top 3 overall male & female, Top 2 masters male & female, Top 2 age group male & female (12 & under, 13 -19, 20-29, 30-39, 40-49, 50-59, 60-69, 70 & over)

### 30k Bike Ride - 10:45 am

An out and back 30K (18.6 mile) bike ride from the Shippensburg Township Park to the trail head in Newville and back to the Shippensburg Township Park. Rest stops will be available along the way with a snack in Newville.

### 15k Ramble - 10 am

A 15K (9.3 mile) hike from the Shippensburg Township Park to the Newville trail head. Water stops will be available. **Transportation will be provided from Newville back to the park.**

From the south use I-81 exit 24, turn left onto Olde Scotland Rd; left onto Fayette Street; right onto King Street (US 11). Turn onto North Queen Street at Sheetz then right onto Britton Road; approximately 1/2 mile to the park.
